- A.2. The effective date of this Amendment to the Great Rivers CESU Cooperative and Joint Venture Agreement shall be determined from the date of the last signature to this Amendment.

### **ARTICLE V. AWARD**

- C.0. Section C.2. is hereby amended and restated in its entirety as follows:
  - C.2. For FSA and NRCS, the indirect cost rate is limited to 10% of total direct costs for colleges, universities, and other nonprofit organizations pursuant to Section 704 of Pub. L. 116-260.
