With the exception of the changes below, all terms and conditions of the Southern Appalachian Mountains CESU Cooperative and Joint Venture Agreement apply to this Amendment, and this Amendment is hereby made part of the agreement.

### ARTICLE I. BACKGROUND AND OBJECTIVES

- A.1. The Bureau of Land Management is included in the Southern Appalachian Mountains CESU as a Federal Agency partner under Agreement # PAA037051.
- I. The Bureau of Land Management (hereinafter called BLM) administers public lands within a framework of numerous laws. The most comprehensive of these is the federal Land Policy and Management Act of 1976 (FLPMA). All Bureau policies, procedures and management actions must be consistent with FLPMA and the other laws that govern use of the public lands. It is the mission of the Bureau of Land Management to sustain the health, diversity and productivity of the public lands for the use and enjoyment of present and future generations (43 U.S.C. 1701 et seq.). In accordance with 43 U.S.C. 1737 (b), the BLM is authorized to enter into the cooperative agreement establishing the Southern Appalachian Mountains CESU to assist in providing research, technical assistance and education.

### ARTICLE III. TERMS OF AGREEMENT

- A.1. The effective date of the Southern Appalachian Mountains CESU cooperative and joint venture agreement is 18 June 1999.
- A.3. The effective date of this amendment shall be determined from the date of the last signature.
- A.4. The expiration of this agreement will not affect the validity or duration of projects which have been initiated under this agreement prior to such expiration.
- C.1. For amendments whose sole purpose is to add a Partner Institution and/or Federal Agency to this agreement, each Partner Institution and Federal Agency currently participating in this agreement will have forty-five (45) days from receipt of the amendment to either sign the amendment or object in writing to the Host University. If a Partner Institution or Federal Agency has not responded after forty-five (45) days from receipt of the amendment, its signature will not be required to make the amendment effective. The Partner Institution and/or Federal Agency being added to the agreement and the Host University shall sign the amendment.
